Tuition Rate increases are considered by FH 2x/year

Please see ECE TUITION bullets below.

Tuition Increases typically take place each January.

Tuition Increases are announced 1.5 months in advance

Monthly Tuition = daily rate x days x 51-52 weeks divided by 12

Room 1 M-F Full Time Early Preschool "e-Pre" (ages 2-4y)

Full Day Class Time is 8:30a-3p, no charge for additional Extended Day (if available)

Room 2 MWF TTh Preschool/Pre-K, Class Only (ages 2.5-4y)

Half Day Morning Class (if available) \$42./day

Half Day Afternoon (if available) \$37./day

Room 5 ABA/ECE Preschool/Pre-K Class (ages 2.5y - 4y)

Full Day Class, no charge for Ext. Day \$59./day (3y+ and PT* and <3y and not PT),

Room 5 (homeroom) Young Leaders Club (K-5th grade)

After School \$30./day (3:30p-5:30p)

Full Day \$59./day, Class Time is 8:30a-3p, no charge for additional Extended Day (if available)

Half Day Morning \$42 Class Time is 8:30a-11:30a, no charge for AM Extended Day or Lunch Bunch (if available)

Half Day Afternoon \$37./day Class Time is 12:30p-3p, no charge for Lunch Bunch or Extended Day (if available)

Sibling discount (oldest child) 10%

*PT = Potty Trained

Carson Smith Scholarship recipients might be offered a deferred tuition option, pending TOP pmt plan.

DEPOSIT

- A deposit is collected in order to finalize a child's enrollment in a specific class and is held until the day following a 4 week disenrollment notice and/or after any outstanding financial resolutions are complete.
- Deposit is REFUNDABLE only if disenrollment policies and procedures have been followed.
- Deposit amount is equal to weekly tuition for ECE clients, or monthly tuition for ECE/ABA clients.
- If your tuition rate changes, we will update your deposit to reflect the updated tuition total. Any credit or difference will be charged or credited within 24-72 hours of tuition changes.

ECE TUITION

- **Monthly tuition is automatically collected on the 15th of the month** for the following month through an ACH method on Brightwheel. If the 15th falls on a holiday or weekend, tuition is processed on the next business day.
- If client ACH method fails, the required CC on file is automatically charged without notice.
- Clients are required to maintain an accurate and signed ACH and CC authorization on file at all times.
- Client is responsible to maintain current ACH information in Brightwheel and to notify FH Director of any updates or changes to their ACH account or credit card on file.
- There is a \$25 fee for each failed attempt to collect tuition through ACH or CC, including a stop payment.
- Ancillary expenses are processed within 24-72 business hours of accrued expenses.
- Ancillary Examples: Additional days, extended day, overtime, program change, updated deposit, lunch fees
- Clients who qualify for DWS or CSS benefits can have tuition adjustments as outlined in separate policies.
